War of 1812 Service Records. Military service records for the War of 1812 are comprised of cards created from muster, pay, receipt and other rolls for soldiers and sailors who served in the war. The information includes name, service dates, terms of service, monthly pay, where they served, and notes of interest. Lake Erie & Mississippi currently available and are 100% complete.
